# Announcing Partial Phase-out of Legacy interfaces for UNIVERGE BX-Series/MP-Series

Due to changing market conditions with more demands towards SIP trunk and endpoints, world-wide component shortage of legacy interfaces and its supplier discontinuation, NEC is partially phasing out products among UNIVERGE BX-series / MP-series, that supports legacy interfaces for EMEA ISDN BRI, Analog FXO trunk and Analog FXS.

Specific items described in this bulletin are becoming End of Delivery (EOD). Last time buy orders should be received by NEC no later than June 30, 2024 for July 1<sup>st</sup> EOD items and September 30, 2024 for Oct 1<sup>st</sup> EOD items respectively, to ensure stock is available from manufacturing. Additional orders past these dates may be accepted where possible until their stocks are depleted.


